	COMMERCIAL FARMER: Fully commercialised farms that are self-sustaining and profitable through most of their sales going to formal markets, with current exporting potential or capability and an annual revenue of over R1 000 000.00.
	FARMER SUPPORT ORGANISATIONS: Any entity that provides potential support to farming organisations. This can include Commodity organisations, Farmer unions, Farmer and other Associations, Agri-tech organisations, and Business or Organisational Support Entities.
